Dear Sir/Madam

We wish to thank you for the opportunity to quote to maintain your swimming pool at the above mentioned address;

### **Weekly Pool Maintenance includes the following (once the pool is in working order):**

1. Once per week basic pool service
2. Testing of water balance (ph, chlorine, alkalinity)
3. Remove and replace pool net (if one is installed)
4. Vacuum pool surface (we use our own equipment)
5. Brush walls, steps and tiles
6. Scoop leaves and debris
7. Backwash and rinse (must be done weekly) **customer's responsibility to top up the water level**
8. Clean out pump and weir catchments baskets
9. Supply and add chemical (salt, chlorine/acid and alkaline) and additional floater per month, needs to be added extra to the swimming pool in the summer month's (October – March at owner's own cost to assist with chlorine levels) not for salt/mineral spring pools or splash pools
10. Chlorine inline feeder pills must be supplied by customer if installed
11. Checking that pool system once cleaned that circulation is trouble free
12. Checking salt chlorinator and clean cells and needed (if installed)
13. Report to client in respect of any equipment problems/failure
14. Notify client of automatic pool cleaner parts that need replacement or other problems which may be found

Any repairs to pump, motor, filter, multiport and automatic pool cleaner, etc. is carried out by PS Pool Solutions once discussed with the client, and/or is to be reported to PS Pool Solutions via the client. Services to be provided by PS Pool solutions for which a quote which will be drawn up and the client

charged for at an additional cost and payable as agreed with client to the service department as per accepted quotation.

The monthly maintenance cost is ..... per month, value added tax included. Weekly pool maintenance accounts are payable at the beginning of each month prior to maintenance starting, payment to be made by the 3<sup>rd</sup> of each month, preferably via direct payment (EFT) or cash.

In the event that monies due for each current month remains outstanding, no maintenance will be done that month and PS Pool Solutions takes no responsibility for the condition of your pool in this event, however arrangements can be made. If this should continue, interest will be charged at back prime overdraft rates.

Please request banking details for EFT:

Either party can cancel the maintenance service with one month's written notice,

Gates must be unlocked on the date of maintenance service, if the team is unable to enter the property, the maintenance service is still payable in full by forfeit. Maintenance service shall continue during winter.

On public/Christian holidays, pool cleaning services will not be rendered but still fully payable (will accommodate accordingly to ensure fluent service).

An escalation of 10% could be rendered annually.

We trust that this agreement is acceptable to you and look forward to keeping your pool clean and sparkling.
